ABOUT PARTICIPATION IN THE ERASMUS+ K107 ACADEMIC MOBILITY PROGRAM

In April 2023, I undertook academic mobility at Lazarski University in Warsaw as part of the Erasmus+ international credit mobility program for teachers (teaching staff exchange).

The main goals of mobility were defined as: improvement of skills and competences; teacher professional development and knowledge exchange; integration of various forms and methods of learning; use of open educational resources; joint and personal training; exchange of scientific knowledge; study of educational programs of the host university; obtaining international teaching experience for students at a partner institution; exchange of innovative pedagogical practices; identification of joint areas of research for further cooperation.

Thus, during my internship, I attended a number of lectures and practical classes: Management of social policy 3rd year / Bachelor of Management, 1-2 group; Qualitative and quantitative methods of forecasting social processes (practical cases) 3rd year / Bachelor of Management, 1-2 group; Managerial economics, 2nd year / Bachelor of Management, 1-3 group; Analysis and management of risks in the economy, 2nd year / Bachelor of Management, 3rd group; Decision-making in conditions of uncertainty and risk, 2nd year / Bachelor of Management, 3rd group.

Attending lectures provided me with an opportunity to gain teaching experience in an international context and strengthen the intercultural competence of all involved parties, in addition, it gave an impetus to the discovery of new ideas for educational and research activities.

A series of meetings with the management of the Faculty of Economics and management of the Lazarus University (Warsaw, Poland) Martin Dahl and Katarzyna Marton-Gadosz, as well as meetings with Erasmus+ curator from the university (Katerzyna Zelinska) gave me an opportunity to discuss the prospects of future cooperation between the faculties, namely: obtaining a double university diploma holders; promotion of student exchange between both institutions; dual management of qualifying works of applicants of both bachelor's and master's level; guest lectures; joint scientific activity, development of the Erasmus+ KA2 joint project, etc.

Also within the scope of the internship, there was a meeting with Gonchar Valentyn, a 2nd year graduate of the Faculty of Economics of BNAU, who is currently studying under the Erasmus+ KA 1 credit mobility program at Lazarski University in Warsaw. Valentyn familiarized all the present with the peculiarities of the work of student self-government at Lazarsk University and in practice allowed to compare teaching methods at the host university with the aim of improving teaching practice at the Faculty of Economics of BNAU.

The exchange program gave me an opportunity for further professional self-improvement, studying the Polish higher education system, and gaining experience in the latest teaching methods. The acquired knowledge will be implemented in the educational process in the field of economic management.

In addition, within the scope of the internship, I had a chance to learn more about cultural traditions of Poland and to visit the historical heritage. I would like to express my sincere gratitude for the excellent organization of the mobility visit, sincere support and positive evaluation of the performed work.

The results of the Erasmus+ International Credit Mobility program, in which I was able to participate, were presented to all employees of the Economics Faculty of the Bila Tserkva National Agrarian University.
